- In addition to having completed all advance arrangements, this Live Animal consignment is properly described and is in a proper condition for carriage by air - according to the current edition of the IATA Live Animals Regulations and all applicable carrier and Government Regulations.
- The animal(s) in this consignment is (are) in good health and condition
- The animal(s) in this consignment has (have) been properly prepared for transport and packed in the appropriate container
- Animals taken from the wild have been properly acclimatised
- All the required export/import and/or transit health certificates, licenses or permits etc. are accompanying the shipment
- The IATA Shippers Certification for Live Animals has been properly completed in duplicate
- The Animal(s) shipment(s) have been properly classified, described, marked and labelled
- This consignment includes species as described in the Convention on International Trade in Endangered Species (CITES)
- Applicable permits/certificates are attached to the Airwaybill
- This Consignment includes species as described in other applicable national legislation
- In the case of Reptiles and Amphibians, the animals contained in this shipment are healthy and they have been examined prior to shipment and are free of any apparent injury and readily recognisable diseases. They are also free of external parasitic infestation, including mites, ticks and leeches which can be readily seen under normal lighting conditions.
- The animal(s) has (have) not been tranquilised without Veterinary approval and supervision (Vet's authorisation letter required)
- The animal(s) has (have) not given birth in the last 48 hours before the start of the journey
- The animal(s) is (are) not pregnant . **Note:** Heavily pregnant animals must not tendered for carriage except under exceptional circumstances and in such a case the animals must be examined by a veterinarian to ensure that the pregnancy is not so advanced that the animals are likely to give birth during transportation or suffer unnecessarily.
- A 24 hour phone number has been supplied on the Waybill for the carrier to obtain instructions from the shipper in the event of an emergency
- The animal has been vaccinated against Rabies *If the animal (s) is under 3 months old - The mother must have been vaccinated) Older animals must have had their vaccine at 3 months of age, then again at 12 months.*
- In the case of Brachycephalic breeds (snub-nosed cats/dogs) - I am aware of the risks related to their transport and accept liability

**NB\*\* As the Shipper, I accept that carriers will not be held liable for any loss, damage or expense arising from death due to natural causes, or death or injury of any animal caused by conducts or acts of the live animal itself or of other animals, such as biting, kicking, goring or smothering, nor for that caused or contributed to the conditions, nature or propensities of the animals. I accept the risk in shipping Brachycephalic breeds (snub-nosed animals). In no event will the carrier be liable for death or injury to an animal attendant caused by the condition, conduct or acts of animals.**
